3. Approval of the Agenda

Mr. Dohm moved to approve the agenda. Ms. Irwin seconded. Carried unanimously.

4. Approval of the October 27, 2025 Meeting Minutes

Ms. Irwin moved to approve the October 27, 2025 meeting minutes. Mr. Henkel seconded. Carried unanimously.

5. Public Comments for Items not on the Agenda

Ms. McLaughlin reminded committee members to express their views with politeness and civility.

7. Committee Action

A. Review and Endorse the 2050 Long Range Transportation Plan (LRTP)

Ms. Dodia provided a presentation (which can be viewed in the November 24, 2025 CAC Agenda), noting that items being presented to the TAC and CAC for endorsement were the Draft LRTP, Draft Technical Compendium, and the Draft Appendices. The Final Draft 2050 LRTP would be presented to the MPO Board for Adoption on December 11, 2025. She requested that Committee members submit all final comments by November 28, 2025.

A group discussion followed in which concerns were raised about long-term congestion and the belief that without a ring-road concept similar to the Sawgrass Expressway, Collier County could face gridlock by 2050. The complexity of the LRTP was noted, including its mix of appealing and challenging elements and the financial and physical limits that shape what can realistically be built. Recent development in Lee County prompted questions about tolling major roads and extending Logan Boulevard into Lee County, though earlier studies found the extension not cost feasible and likely to create new issues. It was emphasized that ongoing FDOT projects such as the widening of I-75 and the planned Everglades Boulevard I-75 interchange are expected to help relieve congestion, and that the LRTP aims to balance growth, feasibility, and limited funding through careful analysis and prioritization.

Environmental constraints related to extending SR 951 and Logan Boulevard northward were acknowledged, along with the need for a broader vision that considers both moving cars efficiently and reducing reliance on them. Questions were raised about light rail, and while it has been discussed and a rail head exists, cost and logistics remain major obstacles. Committee members reflected on past resistance to road widening, the reality of rush hour congestion in all cities, and the importance of updating aging infrastructure and utilities.

The value of studying how other regions address similar challenges was highlighted, especially regarding alternative transportation options. Concerns were expressed that continual road widening could reduce walkability in some areas and that infrastructure planning must keep pace with development while considering year-round conditions rather than only seasonal population. The discussion concluded with a reaffirmation that the 2050 LRTP is focused on finding the right balance among growth, mobility, environmental limits, community preferences, and responsible use of available funding.

Chair Homiak moved to endorse the 2050 LRTP and Mr. Henkel seconded. Mr. DiDonna dissented. Motion passes 7:1.

B. Endorse FDOT Target Zero Safety Performance Targets for Calendar Year 2026

Ms. McLaughlin said that Safety Targets are the only federal Transportation Performance Measure that must be adopted annually. FDOT establishes the State's safety targets in the Highway Safety Improvement Plan. FDOT is maintaining its Target Zero safety performance targets for 2026: zero fatalities and zero serious injuries on Florida roadways. MPOs have the option to either adopt the Statewide safety targets or establish their own quantifiable safety targets. The deadline for the MPO Board to adopt annual safety targets is February 2026.

Ms. Phillips noted that installing audible pedestrian signals at the top ten deadliest intersections in Collier County is a vital need for blind and visually impaired residents and could be incorporated into signal equipment upgrades or replacements. She added that other municipalities, including Miami, have installed audible signals at all intersections, underscoring their recognition as vital for a safe and accessible transportation system.

Ms. McLaughlin agreed that audible pedestrian signals are an important consideration for upcoming signal construction, while congestion issues are also a factor.

Ms. Irwin moved to endorse the FDOT Target Zero Safety Performance Targets for Calendar Year 2026, and Ms. Phillips seconded. Passed unanimously.

8. Reports & Presentations (May Require Committee Action)

A. Overview of Updated MPO Call for Projects Submittal Requirements, Schedule and Funding

Ms. McLaughlin provided a presentation (which can be viewed in the November 24, 2025 CAC Agenda), noting that the draft 2050 Long Range Transportation Plan (LRTP) Cost Feasible Plan reflects the funding reductions in the State's revenue projections. A portion of the MPO's Surface Transportation Block Grant - Urban (SU) annual funding amount is allocated to roadway improvements and the remainder to congestion mitigation and safety projects. Transportation Alternative – Urban (TALU) funding is allocated to bicycle and pedestrian projects. As a part of every LRTP update, the MPO evaluates its SU funding and its call for projects process. The MPO is prioritizing the completion of projects already in the pipeline over funding new projects. Other MPO plans are reviewed, like the Bicycle & Pedestrian Master

Plan for evaluation criteria, as well as the Safety Action Plan. Various funding sources for projects are considered and there are bike-ped projects in the works that may be presented for Committee support to apply for SunTrail or SU Funding in the near future.

Mr. Dohm congratulated **Ms. Arnold** on being appointed to the Naples Airport Authority Board.

Vice-Chair Sasser said he would not be in attendance for the January 26, 2026 CAC meeting.

Endorse an Amendment to the FY 2026-2030 Transportation Improvement Program – three new transit projects: operating assistance, capital to purchase vehicles/equipment, and operating assistance awarded to Easter Seals Florida.

OBJECTIVE: Committee endorsement of an amendment to the FY 2026-2030 Collier MPO Transportation Improvement Program (TIP) and authorizing resolution to add three new transit projects.

CONSIDERATIONS: The Florida Department of Transportation (FDOT) has requested the Collier MPO to amend its FY 2026-2030 TIP for the following transit projects. The State Transportation Improvement Program (STIP) detail provided by FDOT shows the Type of Work for 448810-2 and 446904-1 as OPERATING FOR FIXED ROUTE. Collier County Public Transit and Neighborhood Enhancement has confirmed that two of the projects are for paratransit as noted below and under the Project Description on the project sheets in the attachment.

- **448810-1:** Add a new transit project for capital to purchase vehicles/equipment
- **448810-2:** Add a new transit project for operating assistance for paratransit
- **446904-1:** Add a new transit project for operating assistance to Easter Seals for paratransit

WHEREAS, State and federal statutes, rules and regulations require that each designated Metropolitan Planning Organization develop and adopt a Transportation Improvement Program (“TIP”) and set forth the procedures for doing so; and

WHEREAS, the Collier Metropolitan Planning Organization’s (the “MPO”) TIP may require amending as authorized and required by 23 C.F.R. Part 450 Sections 326, 328, 330, 332 and 334, and by F.S. § 339.175(6), (8) and (13); and

WHEREAS, the Florida Department of Transportation (“FDOT”) requested the Collier MPO to amend its FY 2025/26-2029/30 TIP to add Federal Project Numbers (“FPNs”) for three new transit projects: 448810-1, capital to purchase vehicles and equipment, 448810-2, operating assistance, and 446904-1, operating assistance awarded to Easter Seals Florida, as shown in Exhibit 1; and

WHEREAS, FDOT has submitted a letter to the MPO stating that the amendments are necessary to include in the MPO’s TIP to ensure consistency with FDOT’s Work Program, as shown in Exhibit 2; and

WHEREAS, the MPO announced the TIP Amendment on its website, distributed it via e-mail to various list-serves, and followed all of the steps of its Public Participation Plan through the expiration of the public comment period, which terminated with the MPO’s meeting on February 13, 2026; and

WHEREAS, the MPO has reviewed the proposed TIP Amendment for this project and determined that it is consistent with the MPO’s adopted plans and policies; and

WHEREAS, in accordance with all required State and federal procedures, rules and regulations, including but not limited to the FDOT’s MPO Administrative Manual, the TIP Amendment must be accompanied by an endorsement indicating official MPO approval.

THEREFORE, BE IT RESOLVED by the Collier Metropolitan Planning Organization that:

1. The FY 2025/26 - 2029/30 Transportation Improvement Program Amendment set forth in Exhibits 1 and 2 is hereby adopted.

FDOT Presentation on SR 29 PD&E Studies

OBJECTIVE: For the Committee to receive a presentation on the Florida Department of Transportation's (FDOT) current Project Development & Environment (PD&E) studies for SR 29.

CONSIDERATIONS: FDOT has asked to provide the Committee with an update on its PD&E studies for improvements to SR 29 from CR 846 East to North of New Market Road (FPN No. 417540-5) and from New Market Road/Westclox Road to SR 82 (FPN No. 417540-6). The PD&E study area is broadly depicted below:

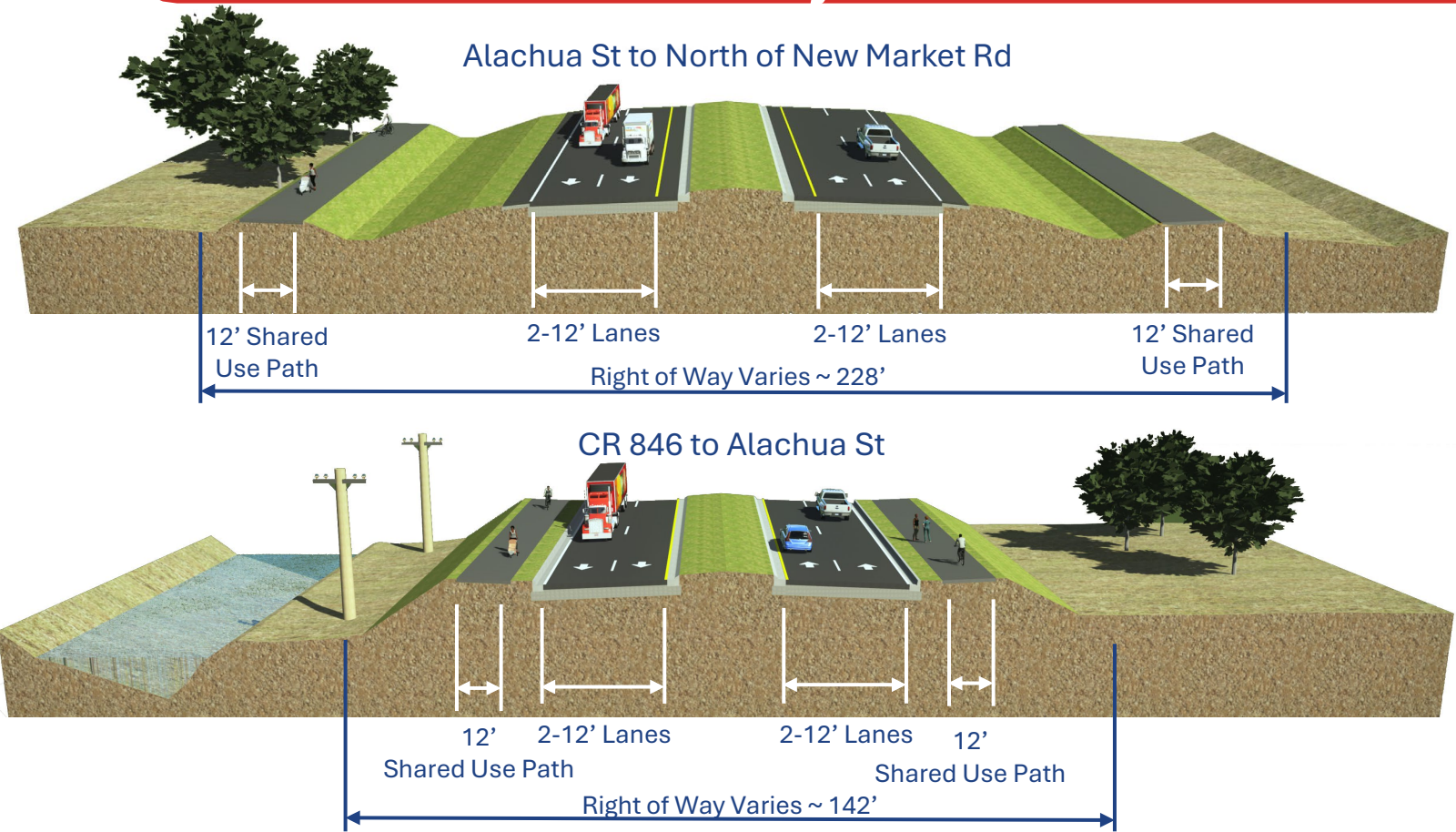

FDOT Project Development Policy effective January 7, 2026

OBJECTIVE: For the Committee to receive a newly issued FDOT policy outlining requirements for FDOT to program funds for transportation construction projects.

CONSIDERATIONS: On January 7, 2026, FDOT's Office of Policy Planning issued a Project Development Policy (**Attachment 1**) outlining new project requirements for transportation construction projects to be included in FDOT's Work Program.

The policy requires the completion of a feasibility study prior to programming the PD&E or PE phase, completing a PD&E within 18 months, and identifying projected funding for construction within 8 years from the start of the PD&E phase.

PROJECT DEVELOPMENT POLICY

It is the policy of the Department that project development phases of a transportation project, including preliminary engineering, project development and environment (PD&E), and design, result in timely project delivery. Upon completion of a feasibility assessment with implementation recommendations, the Department will program and fund preliminary engineering, PD&E, and design phases of transportation projects with the requirement that projected funding is available and programmed for construction within eight (8) years from the start of the PD&E phase.

PD&E studies for new alignment projects and capacity improvement projects must be completed to the maximum extent possible within 18 months after the date of commencement. Any exceptions to this policy must be approved by the Department's Chief Operations Officer prior to programming and funding the project phases.

This policy will be integrated into all aspects of the development process, including manuals, guidelines, Work Program Instructions, and related documents governing preliminary engineering, PD&E, design, construction and funding of transportation facilities.
